Mayor Smith replied that it's a valid suggestion but that the council is at a point when none of them really understand which is why meeting was called.

Council Member Howard addressed Mr. Meza stating that it is his job to be able to present.

Mayor Smith stated that she wants the revenues, expenses, and report by department.

The Council reviewed every line item.

Council Member Tolin addressed that its not that she did not want to go line by line on the budget but if we received \$184,000 which we now have in the general fund because we are now paying PD salaries out of covid funds so if we increase our budget & expenditures by \$64,000 with the increase still leaves us with a net of \$120,000 that we didn't have which seems like a no brainer and not that she doesn't want to review but at a high level we are still \$120,000 ahead.

Council Member De Gobeo agrees that yes we have that money but not because of that we shouldn't be concerned with the amount so we need to try to figure out why this happened and for this not to happen again.

Council Member Tolin made a motion to approve budget amendments in the amount of \$76,095, Mayor Smith seconded the motion. Council Members Howard, Tolin, Gonzalez, Worrell, De Gobeo and Mayor Smith "aye" to approve, motion passed.
