### **CITY MANAGER REPORT**

Rendie summarized what we had for ARPA funds and advised that we did receive the second distribution. She also advised that all ARPA funds need to be designated by 2024 and completed by 2026.

The Street Improvement grant with Clore is being wrapped up, they repoured the hot mix last week on 10/25. Cruz gave his final approval and they are getting all the paperwork together to receive final payment and wrap the finances.

For the 2019 Floods and Tropical Storm Imelda Grant proposal for work on the drainage for Palm, Orange, Ebony and part of Mesquite, We got an RFI requesting updated information which is a good sign and means they are considering us.

CDBG Grant has no word of a gentlemen's agreement yet but we are on the list to be notified, this doesn't affect going forward on our own and went forward with posting RFP and RFQ for the administrator and engineer.

Our Public Works Director submitted his two weeks and his last day was October  $26^{th}$ . We put out an advertisement and are collecting resumes for a new Public Works Director and will keep the council updated.

HOT Tax we have 71 properties registered and are having trouble with even our regular payers to register. The property management companies we can't even get to return our phone calls to register. We are still working on implementing, sending letters and doing correspondence. Rendie explained we are also having trouble with where people are putting the permit number in the listing. Mayor Carter said they need to be putting it in the main description. Rendie advised that we indicated that it needs to be listed but we didn't say where it needs to be listed. Council Member De Gobeo asked it we can ammend our ordinance to reflect that and Mayor Carter answered yes we can.

Rendie advised the Council that she met with Ms. Alexander and went over the process of starting the Parks Master Plan. The next crucial steps will be meeting with the council members individually for input on the councils wants and needs. She will also meet with the Parks board and get their input and then she will do her presentation and public hearing at the December meeting. Then the Survey will be developed and initiated.

Lastly Rendie advised the council on her research for the Library. She met with the librarians for the Middle and High school and they advised that they create things like having adult classes available for example tax preparation, smart phone, and tech help. Rendie is working with the library on implementing those types of informational classes. Pura is also looking for grants for updating furniture with plug ins for charging.

Council Member Tolin commented that she thought that it was great that she went to go talk to the other libraries and suggested maybe to go talk to the larger surrounding cities to see what they are doing. She further commented that Rendie is already doing so much more that has been done in the past and applaud her for that.

Council Member Tolin also thanked Police Chief David and Officer Hernandez for doing all the amazing policing and brought up an email that was sent to the council and thanked them for everything they went thought to save two women.
