CITY MANAGER REPORT

Mayor Carter took a moment to commend all staff on the Christmas Event, stating it was fantastic and the best one yet. Mayor Carter stated that it was a great example of how City Government should work and let city employees use their imagination and expertise. Rendie stated that the Tube slide was a big hit and received a lot of positive reviews. Rendie also advised that even though the cost was not in our budget, Crystal was able to get enough sponsorships to cover the additional big-ticket items that the event almost paid for itself.

Rendie reached out to the surrounding Cities of South Padre Island and Port Isabel to plan calendar events for 2023 so there will be less cross over. Mayor Carter also advised that he also talked with Port Isabel and South Padre Island to work together to make the events more fluent and be able to enjoy each other's events.

Rendie summarized on the Grants. ARPA and 2019 Floods & TS Imelda had no change and the Street Improvement has a public hearing on the 20th to close out the project and finalize the payout.

Rendie updated on the RFQ's for Town Engineer and CPA are still in process.

Rendie advised we have three applications for the Public Works director she is considering including one of the current department workers Roman.

Rendie updated on Hot advising that we had 6 additional properties register in November and 14 collections letters have been sent out. We will be updating the HOT ordinance in January's meeting to update the placement of the HOT permit number to help establish which properties are registered and which are not.

On the Parks Masterplan Rendie updated on the survey that went out on November 29th and so far we have 107 responses. Weekly posts on are scheduled on our FB page and will start on Monday and an additional mass email went out on Friday with a QR code link. Ms. Alexander will do a Public Hearing and Council Update at the January council meeting.

Lastly Rendie briefed the council on the department stats.
