ROLOFF PARK IMPROVEMENTS— Discussion and possible action regarding Texas Park and Wildlife Grant Application 2023 regarding Roloff Park improvements. (City Manager & Patty Alexander)

Rendie and Patty put together a proposal to be considered on Roloff Park, the Texas Parks and Wildlife Grant is due on August 1st. Provided to council is a Sketch and site concept as well as a price estimate that comes in at a million dollars, the grant is matching \$500,000 to \$500,000.

Mayor Carter advised that our town is in need of EMS care and that we would still like to improve our park but now our match will look more in the \$150,000 instead of the \$500,000. Patty advised that we can apply for the small community grant with Texas parks and Wild life at the match of \$150,000 and look into an additional Grant with Valley Babtist.

TRAVEL REQUESTS— Consideration and possible action to approve travel for City Manager and Police Chief to attend TML Annual Conference in Dallas, Texas, October 4-6, 2023. (City Manager)

CAPITAL OUTLAY FUNDS— Review and discussion regarding 2022/2023, AND 2023/2024 capital outlay budget items. (City Manager)

Rendie advised the council that all the Capitol Outlay department expenses have been spent except for Public Works. Manny has taken inventory and advised that what public works could really benefit from would be a lift truck that would be utilized in putting up and removing banners for events as well as cutting palms and other miscellaneous needs. The proposal is to not spend

the \$14,000 but put that towards the next budget to possibly obtain enough funds to purchase a bucket truck at around \$55,000.

Council Member Howard asked for an update regarding the flooding and the pumps. Rendie advised that the angle we are going with is re digging out the coverts to hold the storm water as opposed to pumping out water and sending the water to add to the problem elsewhere. The County and water district do have pumps to use when needed so we can avoid this additional expense.

Council Member De Gobeo asked about the rent on the lift and if it is possible to partner with another city on the lift. The concern is it is a big expense for something that would not be utilized everyday. Rendie advised that there are a lot of things that we are not currently doing that we can start doing with access to the lift like the maintenance on the basketball court and further advised that this is just a proposal for discussion on the upcoming budget.

ARPA FUNDS— Review, discussion, and possible action regarding the approved ARPA funds and projects to date. (City Manager)

Rendie updated the council on the ARPA funds spent and the remaining balance and also advised that the Library weather stripping has gone through procurement and PO's have been done for the Police and Fire vehicles.

2023/2024 FISCAL BUDGET— Consideration and possible action on the 2023/2024 Fiscal Budget.

Rendie advised the council that we have a stricter calendar than prior years and the certified values will be out around the 20th of July. She further advised we need to be a little more proactive and further asked if we would like to schedule any special meetings today. Mayor advised once we get the certified values then we can move forward with scheduling.

RESOLUTION 2023-17— Consideration and possible action on Resolution 2023-017 authorizing membership in the coalition, Cities Served by Texas Gas Services, and suspension of the recommended increase. (City Attorney)

Town Attorney Alan Ozuna spoke to the council on resolution 2023-017 in regards to Texas Gas Service Companies request to raise gas utility rates.
