Rendie advised that we already went over the grants for the most part and no major updates.

Rendie also advised that the website photography link came in today and will be distributed. The website is being made behind the scenes right now to launch in December. Rendie further advised that her goal is to keep the community updated since not everyone gets to come to the meetings and has started doing the Did You Know emails that also include at the bottom the next town council meeting dates. Rendie added that the newsletter is also ready to go out.

Rendie advised that we have started attending Market Days to be even more accessible to the community.

Rendie updated on the library classes advising that Lego night is the most popular currently. Rendie also advised that we will be adding some adult driven classes such as nutrition and cooking classes.

Council Member Howard stated that it was really popular when the library had the authors come and speak. Rendie advised that after covid it has been hard for Pura to get them to come out and speak.

Rendie advised that we had the elections on November 7th and City Hall was not an early voting center this year, not by our choice since the county decides where they are going to be. Rendie added that we did have 477 voters on election day come and vote at City Hall.

Rendie advised that Stripes is currently advertising stores serving margaritas however they are not currently serving them, we are working with them currently on the permitting.

Rendie updated on the events and advised that we are estimating that around five hundred people were at attendance for the Fall Festival. Rendie also advised that we are hosting the holiday appreciation dinner for our volunteer fire fighters on Thursday and advised that our Laguna Vista Town Council – Minutes November 14, 2023 Page **8** of **8**

Christmas event will be on Friday December 8th and will be able to have the surrounding schools perform due to staggering our evens with the surrounding cities. Rendie lastly added the Du it by the Bay event will be coming up in January.

Mayor thanked the Police and EMS Department for doing a great job.

Rendie also added that we had our Veterans Day Ceremony and moved it to our basketball court due to the weather. It turned out very nice and the sound was great at that location. Mayor added we had Norman Esquivel's niece to sing the national anthem and she was great.
